## LIABILITY RELEASE FOR RECREATIONAL/SOCIAL ACTIVITY

The Bay Area SportFishers CLUB activities present the risk of injury. This exculpatory release confirms that the participant who signs below accepts all aspects of that risk for the member and member's family as described in the Club Bylaws.

1. I acknowledge that the recreational activity described above is neither operated nor supervised by Bay Area SportFishers Club and that Bay Area SportFishers Club involvement consists solely of coordinating the activity, equipment, funds and/or permission for the activity.
2. I recognize that the activity presents risks and hazards, known and unknown. I am participating in it voluntarily, knowing it may result in injury to family, others or myself.
3. In return for Bay Area SportFishers Club contribution of facilities, equipment, funds and/or permission, and as a condition of participation, I assume all risk and responsibility for any injury (including death) or damage to my person or property or the persons or property of others, including my family, that may arise in connection with the activity.

I release, discharge and indemnify Bay Area SportFishers Club, its Board of Directors and/or its other members (whether or not acting within the scope of their duties), agents and contractors from all claims or liability for any such injury or damage, regardless of whether they may be wholly or partly negligent or otherwise at fault.

4. In addition, I indemnify Bay Area SportFishers Club, agents and contractors from all loss, costs (including attorneys' fees), expense, damage, claims or liability due to my alleged negligence or fault, including claims or liability relating to injury to others.
5. Any member, including spouse and dependents included in membership, who invites a nonmember agrees that such guest is bound by the same conditions and agrees to so advise the guest.

By signing this release, I certify that I have read and understand it; it binds me, my heirs, representatives, successors and assigns; and it comprises the entire agreement relating to this subject, superseding and other agreements, representations, inducements or understands, whether written or oral.
